Customized Service and Advocacy: Serving the individual needs and advocating on behalf of the 1800 clients and their families we serve annually. Women of the World's case managers support the housing, immigration, social security, and parental rights and needs of their clients. In 2025, we saved our clients \$432,000 in costs like hospital bills, insurance claims, and housing.

Economic Empowerment: This year we helped our clients to apply for 882 jobs, of which they started 82. Our work provided \$2.4 million dollars back to the local economy through helping clients get scholarships, advance in their careers, get raises or start new jobs.

Community Development: We offered 403 hours of English instruction, more than 40 workshop sessions, 4 community events, and 428 hours of one-on-one volunteer mentoring for our clients. One hundred fourteen volunteers contributed 1,499 hours in service directly to our clients.
